**CALL TO ORDER** - Sandy called the meeting to order.

## **GENERAL MEETING BUSINESS**

**Introductions of guests and public comments** - Introductions were made.

**Additions to agenda** – Sandy will give a report on O4AD.

**Review and approval of May 7, 2018 Minutes –**

Minutes were approved as written.

**Announcements –**

- Anne announced – The OLLI open house is scheduled for July 25<sup>th</sup> from 1pm to 4pm in the SOU Stevenson Union.

**SAC Member Update:**

Anne Bellegia, John Irwin and Rosalie Caffrey received certificates of appreciation for their service on the SAC and SAC sub-committees. (2<sup>nd</sup> term completed) Member Renewals 2<sup>nd</sup> Term: John Curtis, Isleen Glatt, Pat Jenkins and Nancy Randolph. Sandy Theis received a certificate of appreciation for the completion of a 2 year service as chair of the SAC. She also was presented with a recognition gavel.

**O4AD Report:**

Sandy reported on the O4AD. She mentioned the National Core Indicators on Aging and Disability Study (on Medicaid). John C. reported on the O4AD as well.

**COMMITTEE REPORTS**

**Executive** – Sandy reported.

- This committee meets quarterly. Did not meet.

**Council Development** – Pat not here.

**Support Services/Nutrition** – Rosalie reported.

- This committee did not meet.

**Communications & Outreach** – Rhonda reported.

- Rhonda mentioned the funding shortfall for the Food & Friends building in Grants Pass is currently down to around \$68,000.
- They talked about creating awareness in the community. They discussed possible grants.
- They discussed sharing information with employers regarding their employees who might be caregivers. They hope to meet with HR administrators as well to discuss any needs.

**Advocacy** – John Curtis reported.

- They discussed the Mental Health care gaps for Medicare recipients and potential solutions to bridge those gaps.
- John shared that the Deaf and Hard of Hearing committee has planned a forum for the Medical Providers. The forum will be held in Jackson County on September 27<sup>th</sup> and on September 28<sup>th</sup> in Josephine County. Last week, they met with attorneys, law enforcement and court employees. It went very well.
- The RVCOG SDS Candidate's Forum will be on September 14<sup>th</sup>.

**Disability Services Advisory Council (DSAC) – John Curtis Reported.**

- The DSAC had a presentation from Tim Fountain at Trans Link about the various services offered.

**Home & Community Based Care – Nancy reported.**

- The committee did not meet.
- Nancy shared about the state's new designation for residential care facilities called the IIC (Intensive Intervention Communities). Sue will email this information to the SAC.

**Field Office Report – Kathie reported.**

- Kathie shared one of the ways the National Core Indicators can be used. They've incorporated it into one of the goal groups in APD. (One of the goals – Broad Awareness and Easy Access)
- Kathie encouraged the SAC to possibly be on a Rule Advisory Committee.
- The group of advocates and the rule & policy makers concluded their negotiations regarding the October changes.

**Director's report – Laura reported.**

- Laura announced that Jim Bachman has been approved as a SAC member by the RVCOG board.
- Laura shared her experience representing Senior and Disability Services at the SOU Enrollment Management Committee luncheon.
- Laura passed out an article from the Mail Tribune on homelessness written by Representative Pam Marsh.
- Laura handed out an article titled "The Biggest Social Security Lies You've Believed".
- Laura also handed out an email from American Society on Aging addressing the decision by the Supreme Court regarding the religious objections in serving the LGBTQ population.
- Laura announced that the Caregiver Conference held on Friday June 1<sup>st</sup> went well with several high quality presentations.
